#### **Biographical Note:**

Marian Pressman was born in Pennsylvania on July 2, 1895 to a Russian mother and a Polish father. During World War I, she sold liberty bonds and sang for the American troops. After marrying Nathan Bloch in the early 1920s, the couple moved to Ardentown, Delaware in 1925. Marian Bloch gave birth to her son, Daniel, at the end of that year.

During the 1930s, Bloch had her own radio program on WDEL. She was later a secretary for the Social Security Administration in Wilmington, Delaware. Following her retirement in 1965, Bloch acted as secretary to the chairman of Ardentown at town meetings. She was a life member of the Arden Club and Hadassah. Marian Bloch celebrated her 100th birthday in July 1995 on Ardentown's Charles Pettit Green. The following year, she moved to Connecticut to be closer to her son. Marian P. Bloch died

on September 16, 1996.

# Scope and Content:

The Marian P. Bloch Collection consists primarily of materials regarding Ardentown leaseholding and land values from the 1930s to the 1960s. It also contains documents related to the Arden School, Arden's Fiftieth Anniversary, Ardentown town meetings, and Frank Stephens.

Most of the materials in this collection relate to the assessment of land values in Ardentown, especially negotiations between the Ardentown Board of Trustees and local leaseholders. These documents include the Ardentown Deed of Trust, a Delaware chancellor's opinion on the 1932 Ardentown Leaseholders case, correspondence to leaseholders regarding assessments, and annual land rent lists. Several of Marian Bloch's rental bills are also included in this grouping.

Other items in this collection include two letters about Ardentown town meetings, two letters regarding the Arden School Budget, an advertisement for Arden's Fiftieth Anniversary celebration, and Frank Stephens' obituary.
