Biographical and Historical Note:

Frank Akutowicz was born on March 7, 1924, to Alfons and Eleanor Akutowicz in Windsor, Connecticut. After serving in the military in occupied Japan immediately after World War II, he graduated from Swarthmore College in 1952. Akutowicz worked as an engineer at the American Viscose Company, retiring in 1974 at the age of 50. He held several patents, including designs for a hydraulic damper, vehicle propulsion apparatus, and marine propulsion fin.

Akutowicz moved to Arden, Delaware, in 1954 where he became an active participant in community affairs, serving on the Community Planning Community and passionately advocating for Georgist principles and sustainable living at Arden Town Assembly meetings. He was deeply involved in the peace and environmental movements, and was an early and ardent supporter of recycling. Akutowicz took an active interest in transportation issues at both the local and national level. He was a key figure in the campaign to prevent the Delaware State Highway Department from building an interchange for I-95 on Harvey Road, citing the devastating social and environmental impact this would have on the Ardens. Akutowicz later studied the environmental impacts of increased traffic, construction, and rezoning on the local community.

Akutowicz lived in Arden for 50 years, and died at the age of 80 on June 3, 2004.

Scope and Content:

This collection contains materials collected and created by Arden resident Frank Akutowicz, who lived in the village from 1954 until his death in 2004. Many items relate to the Arden Archives, Arden committees and governance, and local environmental and transportation issues.

This collection consists of seven series:

Series 1: Personal Papers, 1940-1985 and undated

Akutowicz's personal papers consist primarily of school assignments and related materials, including copies of his high school newspaper, *The Loomis Log.* There are also several undated essays by Akutowicz on life in the Ardens.

Series 2: Arden Archives, 1930s-2000s and undated

This series pertains to the Arden Archives, dedicated to preserving the history of the Village of Arden. Akutowicz served on the Arden Archives Committee for several years and collected information on Arden residents, the history of the Gilds, and the Arden Club. This series also documents the operations of the Archives Committee, including the planning of an exhibition in 1991.

Series 3: Arden and Ardentown Village Assemblies, 1964-2004 and undated

The vast majority of material in this series relates to the Town Assembly of the Village of Arden. Between 1964 and 2004, Akutowicz collected a large quantity of printed

materials from Town Assembly meetings, including meeting minutes, budgets, and reports from various committees. He also saved his extensive handwritten notes on Town Assembly proceedings. This series also contains a small amount of material on the Ardentown Assembly from 1976.

Series 4: Arden Committees and Other Town Governance, 1960-2003 and undated

This series highlights Akutowicz's involvement in numerous village committees during his time in Arden. Most of the material pertains to the Community Planning Committee, but there are also documents related to the Audit Committee, the Civic Committee, and the Safety Committee. There is also material in this series pertaining to elections, assessors and land rents, and the Arden Trustees.

Series 5: Arden Events, Gilds, Institutions, and Publications, 1953-2004 and undated

This series contains a small amount of material related to events in the Ardens as well as various gilds and local institutions. There is a larger number of documents pertaining to Arden publications, including the Town Crier, the Arden Page, and the Arden Book.

Series 6: Organizations and Governance Outside the Ardens, 1961-2004 and undated

In addition to village government and committees, Akutowicz participated in a number of organizations outside of Arden. This series suggests that Akutowicz was heavily involved in the Council of Civic Organizations of Brandywine Hundred in the 1960s and 1970s. He also collected literature related to the peace and environmental movements at both the local and national level.

Series 7: Transportation, Zoning, and Environmental Activism, 1955-2003 and undated

The largest series in this collection relates to Akutowicz's interest in local transportation and zoning issues, especially how they impacted the environment and community life in the Ardens. In the late 1960s and early 1970s, Akutowicz was a key member of the Grubb-Harvey Interchange Committee, which sought to prevent the Delaware State Highway Department from constructing an interchange to I-95 at the edge of the villages. He later monitored the environmental and social impacts of traffic on Harvey Road and became part of the Harvey Road Traffic Calming Committee in the 1990s. Akutowicz also advocated for the protection of local waterways, including Naaman's Creek and Perkins Run. Much of his environmental advocacy focused on sustainable living and "greener" solutions to problems caused by traffic, construction, and other elements of urban life.
